<u>Apartments:</u> (Multiply the number of apartments in the complex by .50 by the amount set forth for a ¾ inch line).

<u>Nursing Homes/Assisted Living Facilities:</u> (Multiply the number of rooms in the Nursing Home/Assisted Living Facilities by .30 by the amount set forth for a <sup>3</sup>/<sub>4</sub> inch line).

<u>Hospitals:</u> (Multiply the number of rooms in the Hospital by .50 by the amount set forth for a ¾ inch line).

## Section 1.02 <u>DEPOSITS FOR UTILITY SERVICES</u>

- a. A minimum deposit of \$107.67 will be charged for water meter sizes up to 1". Meter sizes of 1" and larger will be no less than 1½ times the minimum charge for each meter or the average estimated usage, whichever is greater.
- **b.** A minimum deposit of \$75.00 will be charged for electric accounts.

All meter sockets will be distributed at the warehouse located at 1101 3<sup>rd</sup> Avenue North, Bessemer, Alabama 35020. An electrical permit issued by the City of Bessemer must be presented to receive a meter socket.

c. The maximum deposit at an address will not be in excess of 1½ times the average bill rendered or the estimated bill whichever is greater during the past twelve (12) months. If service is discontinued for non-payment, the deposit will automatically revert to a deposit as described in Section 1.01.

- **d.** Each account requires a deposit and service fee, regardless of the number of accounts or properties the customer has with Bessemer Utilities.
- **e.** When service is upgraded or renewed, the current deposit amount for electric and water must be upgraded. This includes name changes, reconnects, etc.
- **f.** Final bills for refunds or payment due of \$1.00 or less will not be processed.
- g. Finalized accounts will be reviewed for outstanding balances. Credit balances will be transferred to a customer's inactive account if there is an outstanding balance or if there is not an outstanding balance, if the customer has an active account the credit will be transferred to the active account. If the customer does not have an account to transfer the credit to a check will be issued for the credit balance.
